- 1. AHCAB Membership Application Form should be filled properly (Correction/Use of Fluid not allowed).
- 2. Recommended and Seconded by valid AHCAB Members. (Executive Member should not be recommended/seconded any application)
- 3. Two copies of Passport Size Photographs of applicants (Lab Print)
- 4. Copy of Valid Trade License
- 5. Copy of Valid **Commercial** Import Registration Certificate (if applicable).
- 6. Copy of Registration/Incorporation Certificate from RJSC (For Limited Company Only).
- 7. Copy of Memorandum of Article of the Company with Form 12 (For Limited Company Only)
- 8. Copy of TIN/Tax Clearance of the Company and MD (In case of Limited Company)
- 9. Copy of TIN/Tax Clearance of Proprietor (In case of proprietorship)
- 10. Copy of VAT Registration and Monthly VAT Return (Trading-19, Manufacture-7)
- 11. Product List of the Company to be printed in Letterhead Pad and signed by the applicants.
- 12. Organizational Profile of the Company to be printed in Letterhead Pad and signed by the applicants.
- 13. Organogram of the Company to be printed in Letterhead Pad and signed by the applicants.
- 14. Partnership Deed of Agreement (In case of partnership)
- 15. Copy of NID
- 16. Agency/Dealership/Distributorship Agreement or Management License for Animal Health Products (in case of Importer). Following condition for agreement must be fulfill:
 - a. Agreement should in original form.
 - b. Agreement should be countersigned by the Chambers of Commerce of respective principles country or Bangladesh High Commission/Embassy in Abroad.
 - c. Agreement for any banned items will not be allowed.
 - d. Agreement should be valid for next 12 months.
 - e. Principal company should not be allowed to give distributorship for his same product more than one in Bangladesh.
 - f. Principal company should not be allowed to give distributorship for his whole products more than 3 Companies in Bangladesh.
 - g. Principal company should have own website.
 - h. Copies of Principal companies ERC, VAT and Tax Identification should be submitted.
 - j. Principle Companies full address, email ID, Phone number, Website, agreements product list, Terms & Validity of the contract, Guarantees and Claims, Indenting, Incentives, Commissions, Renewal terms, Dispute terms and other related clauses should be mentioned.
 - k. Product Generic and Brand Name should be mentioned in agreement.
- 17. Should have standard warehouse of minimum 1000sft. There should be an AC room with refrigerator, fire fighting equipments, racks, thermometer, hygrometer, shelves and other standard equipments for warehouse.
